Major Projects & Programs

Ultimate Urban Circulator (U²C)

- Phase I Bay Street Innovation Corridor
 - Under construction
- Phase II Skyway Conversion
 - PD&E procurement is currently underway
 - Kick off in Q3 FY2025
- Phase III Neighborhood Extensions
 - PD&E procurement will be advertised in December





Emerald Trail

- 30-mile trail and linear park system connecting 14 urban neighborhoods
- Includes the preliminary/final design and construction of segments 3, 4, 6, 7, and 8
- Funded with Local Option Gas Tax (LOGT) and a \$147 Million Neighborhood Access and Equity Grant from the Federal Highway Administration (FHWA)



MobilityWorks 2.0 Program Accomplishments FY 2024

- Won critical grants to move iconic projects forward
 - Emerald Trail: \$147 Million Largest Federal Grant for the City of Jacksonville
 - Passenger Ferry Grant Program: \$15.6 Million New Ferry Vessel
- Redesigned website and accountability dashboard for MobilityWorks 2.0
- Upgraded 100+ bus stops through community mobility for all projects
- Included workforce development criteria in all procurements
- Developed new MAP book criteria for new amenities





St. Johns River Ferry


- Assumed operations in 2016
- Improvements focused on safety, reliability, and infrastructure of the service
- Phase V completion in December 2024
- Phase VI is in planning and will focus on further improving safety, resilience, and preparing for a second vessel





JTA MobilityWorks

- Last of the JTA MobilityWorks Projects
- Reconstruction of the existing roadway
- Improve capacity and traffic flow through the corridor
- Includes raised medians, utility improvements, closed drainage system, bike lanes, sidewalks and storm water ponds
- Construction Completion in December 2024



Mobility for All

- Northwest Jacksonville
 - 62 bus stops have been constructed to date and 50 bus stops have been assessed for improvement
 - Art competition was held for artwork to be installed in the shelters
 - Enhanced amenities
- Countywide Transit Enhancements
 - 63 bus stops have been completed
 - Currently assessing the next 100 bus stops





Workforce Development

- Included workforce development criteria in RFPs
- Acquired B2G software to track hiring metrics
- Hired two residents for NW Jacksonville Corridor improvement projects
- CareerSource at NW public meetings
